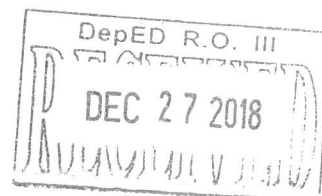

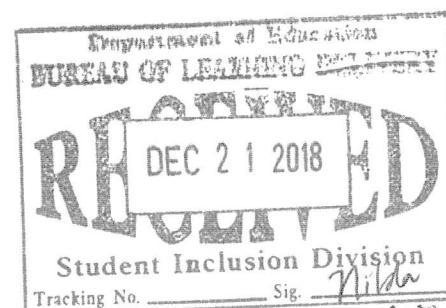
Travel and other allowable expenses of teachers and their learners shall be charged against local funds or other sources, subject to the usual accounting and auditing rules and regulations.
