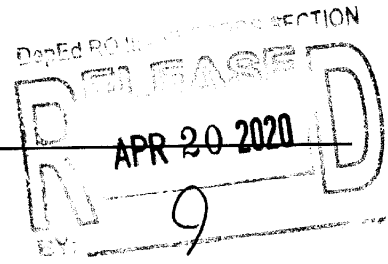

**ADDENDUM TO THE REGIONAL MEMORANDUM NO. 93, S. 2020  
(COMPLETION OF THE GRADE 2 FLEXIBLE LEARNING OPTION  
(FLO)/ALTERNATIVE DELIVERY MODE (ADM) MODULES)**

Regional and Division Learning Education Program Supervisors

1. Relative to Regional Memorandum No. 93, s. 2020, entitled: *Completion of the Grade 2 Flexible Learning Option (FLO)/ Alternative Delivery Mode (ADM) Modules*, a provision on granting service credits to all teachers who will serve as writers, layout artists, and illustrators to the above-mentioned activity which is being done during their summer vacation is hereby added.
2. In accordance to DepEd Order No. 53, s. 2003, re: *Updated Guidelines on Grant of Vacation Service Credits to Teachers*, provision 1, item d, sub-item k, service credits may be granted to all teachers who attended/participated in special DepEd projects and activities which are short-term in duration such as English, Science and Math Mentors' Training, **curriculum writing workshop**, planning workshop, etc., if such are held during the summer vacation or during weekends.
3. As agreed by the CID Chiefs, a 3-day service credits shall be given per finished module.
4. In addition to provision no. 8 of RM No. 93, s. 2020, priority shall be given in the completion of the 1<sup>st</sup> and 2<sup>nd</sup> quarters modules of Grade 2 learning areas and these shall be emailed at [region3@deped.gov.ph](mailto:region3@deped.gov.ph), cc: nestor.nuesca@deped.gov.ph on or before April 30, 2020. However, finished quarters 3 and 4 modules may also be submitted.
5. All information stated in the said Memorandum shall remain in effect.
6. Immediate dissemination of and strict compliance with this Memorandum is directed.
