**DAILY ONLINE HEALTH DECLARATION FORM REGISTRY IN PUBLIC
ELEMENTARY AND SECONDARY SCHOOLS**

To: Public Elementary and Secondary School Heads
Teaching and Non-Teaching Personnel
All Others Concerned

1. All Teaching and Non-Teaching personnel in all Public Elementary and Secondary Schools in Science City of Munoz are hereby directed to fill out the online health declaration form registry on a daily basis before entering all School premises and DepEd Offices to the google sheet link provided: tinyurl.com/HealthDeclarationForm effective immediately except for teachers who are on vacation, however, if they are advised to report to schools through a corresponding communication they shall accomplish the said registration form.
2. The objective of this activity aims to:
 - a. Provide in full honesty the personal and health information of all personnel who are physically reporting in schools.
 - b. Declare history of travel or any exposure to a probable, close contact, suspect or confirmed COVID-19 patient in the last 3 days for the purpose of health assessment, treatment and contact tracing as needed in the time of COVID-19 Pandemic.
 - c. Subject oneself to daily checking of body temperature, once before entering DepEd Offices and schools to ensure the health, safety and well-being of all personnel in the institution.
3. Rest assured that whatever information that all concerned provide shall be treated with utmost confidentiality in accordance with the Data Privacy Act of

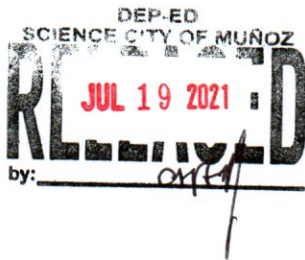
