WEBINAR ON INSTITUTIONALIZING THE OPEN HIGH SCHOOL PROGRAM (OHSP) IN JUNIOR HIGH SCHOOL

- To: Public Secondary School Principals/OICs Department Heads Flexible Learning Options (FLO) Coordinators Guidance Counselors/Advocates
- 1. It is an absolute right of every individual to receive education which will enable that person to become a productive citizen. The constitution, recognizing this right, explicitly mandates that every individual regardless of age, sex, race, political or socio economic status must enjoy access to quality and relevant basic education. To this end, the Bureau of Secondary Education has designed the Open High School Program (OHSP) as an alternative mode of secondary education. The program offers an opportunity to those learners at risk of dropping out who desire to complete the high school curriculum but were put into difficult situation.
- 2. In view of the above, the Schools Division of Science City of Muñoz through the Curriculum Implementation Division (CID) will conduct a Webinar on Institutionalizing the Implementation of Flexible Learning Options, particularly the Open High School Program (OHSP) in Junior High School to prevent potential school leavers on August 13, 2021 at 8:00 AM.
- 3. This activity aims to:
 - a. ensure the availability of learning materials in FLO,
 - b. capacitate the participants in the proper implementation of the OHSP in this of pandemic situation in the country, and
 - c. adopt the policy guidelines on the implementation of OHSP.
- 4. The participants to this activity are the public secondary school heads, department heads, FLO coordinators and guidance counselors/advocates.
