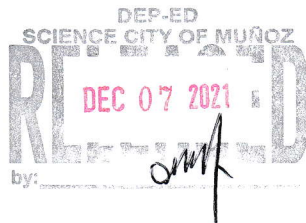

No. of Level 2 Schools (Maturing)	<ul style="list-style-type: none">● For the Elementary schools, the data shows 6 out of the 20 schools increased its Level of Practice from Maturing to Advancing.● Data for the secondary reflects 2 out of the 4 schools increased from Level 2 to Level 3
No. of Level 3 Schools (Advanced)	<ul style="list-style-type: none">● SBM Level of Practice in the Elementary increased from 9 in 2019 to 16 in 2020 schools with Level 3 practice; and● Secondary Schools rose from 5 to 6 schools improving from Level 2 to Level 3 practice.
