- 1. The recruitment, selection, and hiring of teacher-applicants for the Schools Division of Science City of Muñoz for the School Year 2022-2023 shall be conducted from January May 2022 in accordance with DepEd Order No. 7, s. 2015: Hiring Guidelines for Teacher I Positions (Kinder, Elementary and Junior High School).
- 2. Anent to this, all interested teacher-applicants are advised to submit on or before January 31, 2022, a duly signed copy of their letter of intent. Applicants may opt to submit a hard copy at the SDO Records Unit or a soft copy in pdf file via e-mail at munozscience.city@deped.gov.ph, using the subject line: Kinder/Name of Applicant.

- 3. The submission of all other requirements and the schedule of paper evaluation, interview, and demonstration shall be announced on a separate Division Memorandum in consideration of the rapidly increasing new cases of COVID-19 brought by new variant, Omicron.
- 4. Submitted letters of intent shall be the basis for the preparation and coordination of the Division with the Bureau of Education Assessment (BEA) for the administration of English Proficiency Test (EPT) for teacher-applicants.
- 5. Teacher-applicants who are qualified to take the EPT are those first-time takers and those who are non-takers for at least 2 years.
- 6. Qualified EPT takers are advised to accomplish the online EPT registration through the link https://bit.ly/EPTTakers.
