



REGION-WIDE ORIENTATION OF PUBLIC-SCHOOL HEADS ON THE PROGRESSIVE EXPANSION OF LIMITED FACE-TO-FACE CLASSES

To: Assistant Regional Director School Division Superintendents Regional Composite Team All Others Concerned

- 1. Corresponding to the approval of the recommendation for the progressive expansion of limited face-to-face classes by the President last January 17, 2022, Office Order OO-OSEC-2022 Interim Guidelines on the Expansion of Limited Face-to-Face Classes and recategorization of provinces in Central to Alert Level 1 and 2, DepEd Regional Office III enjoins the commencement of the progressive expansion phase from K to 12 including SPED NG for all public and private elementary, junior and senior high schools and SUCs/LUCs for SY 2021-2022.
- 2. Relative to this, DepEd Regional Office III Composite Team shall conduct Region-wide Orientation of Public-School Heads on Progressive Expansion of Limited Face-to-Face Classes from March 15-18,2022. Participants in this activity are Schools Division Composite Teams, Public Schools District Supervisors, and all public-school heads. The Schools Division Office shall identify the venue for the activity and prepare the list of participants per Batch (See Annex). The HRTD Fund shall be used in the conduct of the activity. Public health protocols for Alert Levels 1 and 2 shall be strictly observed for the entire duration of the activity.
- 3. Meanwhile, an orientation meeting for the Regional Composite Team members shall be conducted on Monday, March 14, 2022, from 9:00 am onwards at the NEAP. This Regional Memorandum shall also serve as the Travel Authority of the concerned Regional Personnel on both mentioned activities.
