REITERATION ON STRICT ADHERENCE ON THE REQUIRED HEALTH STANDARDS AND SAFETY PROTOCOLS IN BASIC EDUCATION OFFICES AND SCHOOLS DURING ALERT LEVEL 1

1. Due to the continuous threat of OMICRON variants and increasing number of COVID-19 cases in the locality, the Schools Division of Science City of Munoz is deeply committed in ensuring the health and safety of all its learners and constituents. In connection with this, **all are hereby directed to strictly adhere to the required minimum public health standards and safety protocols in all Basic Education Offices and Schools at all times in accordance with DepEd Order No.14 s.2021 titled Guidelines on the Required Health Standards in Basic Education Offices and Schools.**
2. Even with the ongoing National COVID- 19 Vaccination in our country, adherence to the minimum Public Health Standards remains the cornerstone in the prevention and mitigation against the COVID- 19 pandemic. Protocols such as **truthful declaration of travel and medical history, prompt coordination and referral to the Baranggay Health Emergency Response Team (BHRT) once flu like signs and symptoms were exhibited, wearing of medically accepted face mask, social distancing of at least 1.5 to 2 meters, frequent handwashing, alcohol-based hand rub, disinfection of frequently held**
