CONDUCT OF DENTAL SERVICES TO TEACHING AND NON-TEACHING PERSONNEL

To: Public Elementary School Heads
School Health Coordinators
All Others Concerned

1. In connection with the DepEd Order No. 041, s. 2021, or Guidelines on the implementation of School Dental Health Care Program (SDHCP) this Division through the School Health and Nutrition Section (SHN) will conduct dental services to teaching and non-teaching personnel.
2. The Program aims to provide access to dental services among DepEd personnel who need preventive and curative services including immediate dental and emergency care.
3. The Division dentist will be stationed at the functional school clinics in Munoz Central School and Munoz North Central School to provide the services.
4. Services includes:
 - a. dental check-up;
 - b. prescription of drugs;
 - c. tooth extraction;
 - d. oral prophylaxis; and
 - e. referrals if necessary
5. The division nurse will assist the dentist and take their blood pressure.
6. Clinic Schedule:
 - a. Tuesday- Munoz North Central School
 - b. Wednesday- Munoz North Central School
 - c. Thursday- Munoz Central School
 - d. Friday- Munoz Central School
