COMPOSITION OF THE COMMITTEE ON DECORUM AND INVESTIGATION (CODI)

- 1. In accordance to section 14, Rule 3 of the 2017 Rules on Administrative Cases in the Civil Service (2017 RACCS) which states that the Committee on Decorum and Investigation (CODI) shall be created in all national or local agencies of the government, state/local colleges, and universities, including government-owned and controlled corporation with original charters.
- 2. Furthermore, such ruling states that a CODI shall be composed of at least one (1) representative each from the management, the credited union, the second level employee, and the first level employees, duly selected by the unit concerned.
- 3. Thus, the Committee on Decorum and Investigation is hereby created and shall be composed of the following:

 - a. Receives complaints of sexual harassment;
 - b. investigates sexual harassment complaints in accordance with the prescribed procedures;
 - c. submits a report of its findings with the corresponding recommendation to the disciplining authority for the decision; and
 - d. leads the conduct of discussion about sexual harassment within the agency or institution to increase understanding and prevent incidents of sexual harassment.
- 5. The members of the CODI shall serve a term of three (3) years unless replaced earlier.
