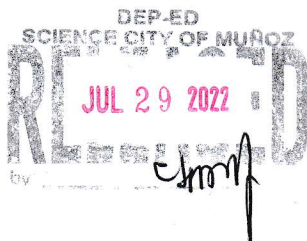

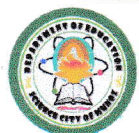
**OBSERVANCE ON THE CELEBRATION OF 33<sup>RD</sup> WHITE CANE SAFETY DAY**
