**CONDUCT OF DENTAL SERVICES TO ALL PUBLIC ELEMENTARY LEARNERS**

1. In connection with the DepEd Order No. 041, s. 2021 or Guidelines on the implementation of School Dental Health Care Program (SDHCP) this Division through the School Health and Nutrition Section (SHN) will conduct dental services to Public Elementary learners.
2. The Program aims to provide access to dental services to all learners who need preventive and curative services including immediate dental and emergency care.
3. The Division dentist will be stationed at the functional school clinics in Munoz Central School and Munoz North Central School to provide the services such as:
  - a. dental check-up
  - b. prescription of drugs
  - c. tooth extraction
  - d. oral prophylaxis
  - e. referrals if necessary
4. Learners must bring their Dental Health Forms to record the procedure.

Monday- 9:00 am to 12:00 pm ( Munoz Central School )  
Tuesday- 8:00 am to 12:00 pm ( Munoz Central School )  
Wednesday- 8:00 am to 12:00 pm ( Munoz North Central School )  
Friday- 8:00 am to 12:00 pm ( Munoz North Central School )

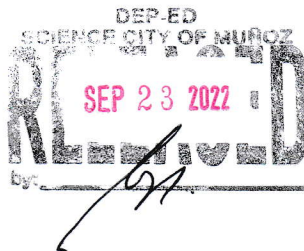
