- orient and conduct capacity-building activities for School Heads and other personnel;
- 4.2 formulate operational guidelines and/or implementation plans which are consistent with those of the RO's and with national policies;

- 4.5 administer situation assessment and needs analysis of schools in implementing the guidelines;
- 4.6 ensure compliance of procedures in the removal from office of SGC members;
- 4.7 maintain a list of SGC members who have been disqualified and provide relevant, timely and appropriate technical assistance to the schools;
- 4.8 provide proper and timely information on the progress of the implementation of activities supportive of SIP;
- 4.9 monitor performance of SGCs vis-a-vis implementation of programs, projects, and activities of the council;
- 4.10 track and analyze the implementation and results of Technical Assistance interventions; and
- 4.11 monitor the implementation of the guidelines.
