REITERATION ON THE CONDUCT OF DRRM ACTIVITIES, SAFETY MEASURES, AND PREPARATION AND SUBMISSION OF REPORTS

To: Assistant Schools Division Superintendent Chief Education Supervisors Public Elementary and Secondary Schoolheads All Others Concerned

1. Pursuant to Republic Act 10121 entitled *Philippine Disaster Risk Reduction and Management Act of 2010* which mandates all national government agencies to institutionalize policies, structures, coordination mechanism and programs with continuing budget appropriation on Disaster Risk Reduction and Management (DRRM) from national to local levels, this Office instructs all public schools to strictly adhere with the conduct of DRRM activities and safety measures in the schools, including report preparation and submission.

2. Further, to provide safety and protection among learners and personnel from unnecessary physical dangers that they may be exposed to during natural disasters and calamities and to properly guide our schools in the implementation of DRRM PPAs, the School Governance and Operations Division through Disaster Risk Reduction and Management (SGOD-DRRM), reiterates compliance to different activities, to wit;

4. Moreover, all schools should observe compliance with DepEd Order No. 021, s. 2023, as follows:

"Schools shall ensure that school grounds, classrooms and its walls, and other school facilities are clean and free from unnecessary artwork, decorations, tarpaulin, and posters at all times . . . Classroom walls shall remain bare and devoid of posters, decorations or other posted materials. Classrooms should not be used to stockpile materials and should be clear of other unused items or items for disposal."

5. For compliance in SGOD v. 3 Office functions, all schools must prepare a monthly report, to be validated by the Division DRRM Coordinator during school monitoring.

FIRE SAFETY MEASURES

(in reference to DO 28, s. 2016 and RM No. ESSD-2024-035)

- 1. Formulation of Fire Escape Plan.
- 2. Ensure the presence of fire escape routes and exit paths which the personnel and learners should be aware of. These should be clearly marked with readable signage.
- 3. Inspect doors and windows of buildings and ensure that they are easy to open.
- 4. Ensure that exit/escape paths are free of obstruction.
- 5. Trim shrubs and trees in the vicinity
- 6. Enforce proper waste management. Clear the offices and school grounds rom waste. Combustible waste such as papers, wood plastics, paint tins, flammable liquids should not be stored in heaps or loose in the open. Suitable receptacles such as litter bins, recycling bins, etc. should be provided.
- 7. Conduct regular safety inspection and take necessary action to repair or replace defective wirings, light bulbs, etc. and disconnect the electrical wirings on a condemned building.
- 8. Demand and practice good office and school keeping practices, e.g. inspect laboratories daily; unplug electrical wirings and turn-off lights.
- 9. Formulate fire safety and control measures for contractors as they can increase the risk of fire and cause obstruction to escape routes.
- 10. Ensure the provision of fire safety and protection equipment, which should not be limited to fire extinguishers. Other equipment
