SUBMISSION OF CLASS PROGRAM FOR THE IMPLEMENTATION OF BLENDED LEARNING MODALITY

To: Assistant Schools Division Superintendent
Chief Education Supervisors
Schoolheads, Public Elementary/Integrated/Secondary Schools
All Others Concerned

- 1. In compliance with the directive from the Office of the Provincial Governor, all schools in Nueva Ecija shall implement a blended learning modality as a response to the prevailing extreme heat in the province. This modality shall consist of face-to-face classes in the morning, starting from 6:00 a.m. to 12:00 pm, and distance learning (modular or online) in the afternoon.
- 2. In accordance with this directive, this Office, through the School Governance and Operations Division (SGOD) instructs all public elementary, integrated, and secondary schools to submit their respective class programs for the blended learning modality on or before April 11, 2024.
- 3. The class schedule will undergo evaluation by the Curriculum and Implementation Division (CID) to verify adherence to the prescribed standard duration of minutes and days allocated for each learning area.
- 4. The SGOD and CID will oversee the implementation of the blended learning modality.
- 5. Furthermore, schoolheads are reminded of their role as instructional leaders and are expected to:
 - a. Arrange for a reliever or substitute teacher to manage classes in case of teacher absences and attendance to required activities.
 - b. Strictly implement the school's class program, ensuring teachers' adherence to the scheduled time for each learning area based on the approved class program.
 - c. Ensure that break time schedules are adhered to accordingly.
