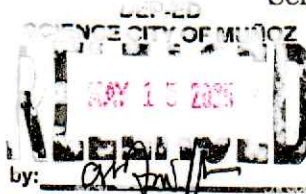



The Department of Education (DepEd), through the signed Memorandum of Agreement (MOA) dated January 8, 2025, entered into a partnership agreement with the Bangko Sentral ng Pilipinas (BSP) and BDO Foundation to further strengthen the integration of financial literacy program in the K to 12 Curriculum.

In line with BSP's broader financial inclusion strategy and the Department's goal of integrating financial literacy into basic education, the partnership brought the development of financial education (FinEd) learning resources (LRs). These LRs are available for download through the Learning Resource (LR) Portal <https://lrnds.deped.gov.ph> which can be accessed by using the keyword: *financial education*.
