CONDUCT OF BACKYARD CAMPING

To: Assistant Schools Division Superintendent Chief Education Supervisors Public and Private Elementary and Secondary Schoolheads School BSP and GSP Coordinators All Others Concerned

- 1. In line with DepEd Order No. 68, s. 2003 titled *Revitalizing the Boy/Girl Scouting Movement in Schools*, this Office announces the conduct of School Backyard Camping on October 2025 as Boy Scout of the Philippines (BSP) and Girl Scout of the Philippines (GSP) Camping Month for Elementary and Secondary Schools.
- The main objective of this program is consistent with the Department's mission to enhance, support, and develop boys and girls into wellrounded individuals with exemplary character.
- 3. All registered Elementary, Secondary and Senior High School Scouts are enjoined to participate in this activity.
- 4. Prior to the conduct of backyard camping, schools shall submit request letter addressed to Schools Division Superintendent containing and ensuring their compliance with the following:
 - a. schedule of School Backyard Camping (must be held from Friday 1:00 p.m. to Saturday)
 - b. adherence to the non-disruption of classes policy,
 - signed SPTA resolution and minutes of the meeting (re: conduct of BSP / GSP activities),
 - d. Contingency Plan,
 - e. Parents Consent,
 - f. certification from the schoolhead that the proposed activity is voluntary and does not constitute equivalent grades or corresponding special projects or activities, and
 - g. approved request submitted to the LGU/Barangay for the security and assistance of all learners and teaching and nonteaching personnel to be involved.
