### SCHOOLS' PREPAREDNESS MEASURES FOR EARTHQUAKE

To: Assistant Schools Division Superintendent  
Chief Education Supervisors  
All SchoolHeads  
All Others Concerned

1. The Philippines is situated in the Pacific Ring of Fire, which makes it prone to natural disasters such as earthquakes, volcanic eruptions and other geological hazards. These hazards, coupled with vulnerabilities, increase the risk of disasters in schools and communities. This natural vulnerability puts many schools at risk, especially those with older or poorly constructed buildings. In the event of strong earthquakes or eruptions, students and staff may face serious safety threats. To reduce these risks, it's essential for schools to improve disaster preparedness and strengthen infrastructure.
2. Relative to this, schools are directed to implement the following mitigation measures:
  - accomplish Family Earthquake Preparedness;
  - conduct of Unannounced Earthquake Drill;
  - ensure that schools have safe open space for evacuation area;
  - disseminate IEC on what to do before, during and after earthquake in the group chats of learners/parents; and
  - secure a copy of Contingency Plan and Learning and Service Continuity Plan;
3. Attached is the implementing guidelines for the accomplishment of the forms listed.
4. Immediate and wide dissemination of the Memorandum is desired.

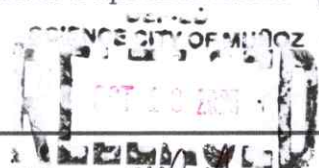

1. DepEd Order No. 27, s. 2015 titled *Promoting Family Earthquake Preparedness*, which aims to guide learners and their family about earthquake preparedness.

### **GUIDELINES IN THE CONDUCT OF DEPED ORDER NO. 53, S. 2022 "UNANNOUNCED EARTHQUAKE DRILL"**

1. All public elementary and secondary schools are instructed to conduct unannounced earthquake drill every first and third week of every month. The conduct of the drill shall take no more than one (1) hour to ensure the minimal disruption of classes.
2. For cases where there is a conflict with the schedules of equally important school activities, School Heads shall determine the best available schedule for the conduct of drills.

### **GUIDELINES IN THE ACCOMPLISHMENT OF LEARNING AND SERVICE CONTINUITY PLAN (LSCP) IN REFERENCE TO DEPED ORDER NO. 22, S. 2024**

1. Based on DepEd Order No. 22, s. 2024, all schools must develop/update their LSCPs in preparation for class suspensions.
2. Data gathering such as ADMs, resources, protocols, make-up classes, resource allocation, school-based services must be included in the crafting of LSCP.
3. The hardcopy of the plan must be submitted to the Schools Division Office for review of School Governance and Operations (SGOD) and Curriculum Implementation Division (CID) chiefs, and then endorsed to the Schools Division Superintendent, for approval.
4. The deadline for submission of the hardcopy of LSCP is until November 7, 2025.
