PARTICIPATION IN THE 54th PROVINCIAL JAMBOREE

To: Assistant Schools Division Superintendent
Chief Education Supervisors
All Public and Private Elementary and Secondary Schoolheads
All Others Concerned

1. In view of the Boy Scout of the Philippines Nueva Council Memorandum No. 25, s. 2025, this Office encourages all public and private elementary and secondary schoolheads to send their registered scouts and scout-leaders to join in the 54th Provincial Jamboree with the theme "*Service, Innovation, and Scouting for All,*" on January 26-31, 2026, at BSP Camp, Palayan City.
2. A jamboree fee of seven hundred pesos (P700.00) shall be charged to each delegate to cover expenses on souvenir items such as t-shirt, bag, ID with lace, certificates, program materials, and other incidental expenses to be incurred in the entire duration of the jamboree.
3. The delegates shall bring the following:
 - a. food supplies, pail, big container drums, and extension wire;
 - b. parent's permit, medical certificate, first aid kit, tents, beddings, and BSP uniform (Type A, Type B or Type C) with rubber shoes for outdoor activities; and
 - c. notebook, pentel pen, crayons, ballpen, pencil, flashlight, toiletries and sack or garbage bag.
4. Schoolheads must do necessary measure to ensure that participating learners be given activities so that they cope the lessons.
5. Related to this issuance, there will be a meeting of the BSP coordinators on January 16, 2026, 3:00 p.m. at the SDO Teacher's Hall.
6. To ensure learning continuity, there must be relieving teachers who will take charge of classes of the teacher-participants.


