**SUBMISSION OF SCHOOL ACTION PLAN FOR OPLAN KALUSUGAN SA
DEPED FOR FISCAL YEAR 2026**



1. In accordance with DepEd Order No. 028, s. 2018, titled *Policy and Guidelines on Oplan Kalusugan sa Department of Education (OK sa DepEd)*, which aims to promote and provide learners and DepEd personnel with sustainable, holistic school health and nutrition programs and to ensure a safe and healthy school environment, all public elementary and secondary schools are hereby mandated to adopt and implement the said policy. Schools are further enjoined to undertake locally initiated programs, projects, and activities aligned with the six (6) flagship programs under Oplan Kalusugan sa DepEd.
2. The six flagship programs include: (1) School-Based Feeding Program; (2) Water, Sanitation, and Hygiene (WinS) Program; (3) Adolescent Reproductive Health Program; (4) National Drug Education and Prevention Program; (5) School Mental Health Program; and (6) the provision of basic medical, dental, and nursing services, including other nutrition support services such as Deworming in Schools, the School-Based Immunization Program, Gulayan sa Paaralan, and strict compliance with the Policy and Guidelines on Healthy Food and Beverage Choices in Schools and in DepEd Offices, as stipulated in DepEd Order No. 13, s. 2017.
3. In this regard, all public schools are hereby instructed to submit their School Action Plan (hard copy) for Fiscal Year 2026 to the Schools Division Office on or before February 6, 2025.
4. The submission of the School Action Plan aims to clearly define goals and objectives, translate these into specific and actionable steps, identify necessary resources for program implementation, establish accountability among implementing teams, and provide a structured framework for monitoring and evaluating program effectiveness.
