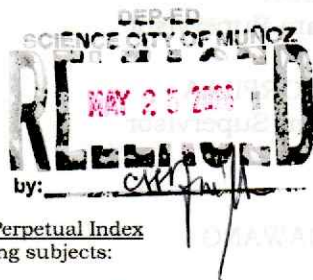

4. Unless sooner removed for a cause, the members of the BAC shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Head of the Procurement Entity (HOPE).
5. Upon the expiration of the terms of the current members, they shall continue to exercise their functions until the new BAC members are designated.
