Pursuant to DepEd Order No. 28, s. 2018, titled *Policy and Guidelines on Oplan Kalusugan sa Department of Education*, the Health and Nutrition Unit under the Schools Governance and Operations Division shall conduct Learners' Health Assessment (LHA), including vision and auditory screening, health education sessions, and the provision of basic medical, dental, and nursing services for learners in public elementary and secondary schools.
