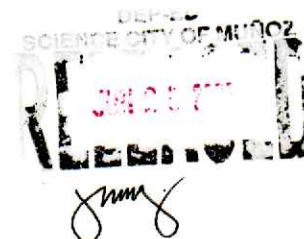

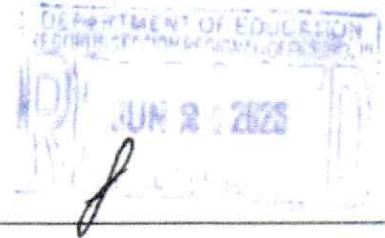

This Office, through the Curriculum and Learning Management Division (CLMD), hereby informs all concerned offices and schools that the conduct of the Regional Pre-Assessment in all learning areas for Key Stages 1 to 3 is officially cancelled. For reference, the said assessment was originally scheduled on June 10-11, 2026, pursuant to Regional Memorandum No. 180, s. 2026, and was subsequently rescheduled to June 25-26, 2026, through Regional Memorandum No. 198, s. 2026. However, the Regional Office has issued a directive formally cancelling the conduct of the assessment.
2. This action is intended to ensure the uninterrupted implementation of the instructional block and to maximize instructional time. In view thereof, all Division Offices and Schools are directed to immediately disseminate this information to all concerned personnel and cease any further preparations related to the Regional Pre-Assessment. The cooperation and understanding of all concerned are earnestly requested as we continue to align our programs and activities with the directives and priorities of the Department.
